## **Recent bad press**

We are aware that osteopathy has had some bad press recently. We would like to represent our view of the role osteopathy has in health care provision.

Patients can choose to see their osteopath directly (without referral), this makes osteopathy a primary health care service. As primary health care practitioners, we offer patients osteopathy and by doing so we give patients a choice in their health care provision.

Osteopathy is more than hands on therapy alone, it is a complex intervention based on many interacting components. An osteopath also provides education, delivers public health advice, offers support, reassurance, guidance and encourages and enables patients and carers (for those who treat children) to have confidence in themselves to manage their own or others conditions. Osteopaths also act to refer patients to other clinicians when they feel this would be more appropriate for the patient.

All these components are an important part of the care offered to our patients and there is an emerging body of evidence illustrating the therapeutic value of these. We will be monitoring the literature in this field and NCOR will disseminate accordingly.

NCOR's next big piece of work, partly funded by donations from osteopaths in the UK and abroad, is to review the literature on the manual therapy treatment of babies and children and look at the 'softer' but very important non-clinical outcomes in patients.
